Introduction

- \cdot We are committed to safeguarding the privacy of our website visitors, service users and customers.
- This policy applies where we are acting as a data controller with respect to the personal data of such persons;

in other words, where we determine the purposes and means of the processing of that personal data.

• Our website incorporates privacy controls which affect how we will process your personal data. By using the

privacy controls, you can specify whether you would like to receive direct marketing communications and limit

the collection and use of your personal data for that purpose.

- We use cookies on our website. Insofar as those cookies are not strictly necessary for the provision of our website and services, we will ask you to consent to our use of cookies when you first visit our website.
- In this policy, "we", "us" and "our" refer to Turmeric Group Ltd

The type of personal information we collect

We currently collect and process the following information:

· Personal identifiers, contacts and characteristics (for example, name and contact details)

Collection of personal data

Turmeric Group processes personal data about contacts (existing and potential clients and/or individuals associated with them).

This includes name, employer name, contact title, phone, email and other business contact details required for invoicing. In addition, we may record information about our interactions with contacts.

Administering, managing and developing our businesses and services

This includes:

- · managing our relationship with clients;
- developing our businesses and services (such as identifying client needs and improvements in service delivery
- and learning more about a client relationship opportunity);
- administering and managing IT systems, websites and applications; and hosting or facilitating the hosting of events

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- · Scheduling an appointment with you or your executive staff
- · Producing a Coaching Proposal
- Invoicing and billing



Transfers of personal data - Cross-border transfers

We share your data with a data controller based outside of the UK & EEA bound by instructions, both within the Turmeric network who support us in our activities, e.g. as part of the administration purposes. In the course of our activities, we use a private network IT service provider bound by instructions, which provides services for the operation, maintenance and care of the IT systems and applications used by the Turmeric Group processor.

The company has intra-group data sharing arrangements, based on GDPR Commission approved standard contractual clauses. The UK International Data Transfer Addendum ("UK Addendum") issued by the UK's Information Commissioner's Office to provide a legal mechanism to transfer Personal Data from the UK. This mechanism is required under UK data protection law (known as UK GDPR) and is incorporated into our agreements,

These standard contractual clauses provide specific contractual protections designed to ensure that your personal data is subject to adequate and consistent level of protection when transferred outside the UK & EEA.

Information collected through your business relationship with Turmeric Group Limited

We may obtain information about you from interactions and engagements related to your professional involvement with Turmeric Group Limited. This could include details gathered during business meetings with Turmeric employees or collaborators, as well as from your participation in events, conferences, or other initiatives organized by Turmeric Group Limited.

Turmeric Group Limited marketing activities

Subject to your express consent and until you withdraw said express consent or otherwise opt-out of our use of your personal data, we may use your personal information for our marketing activities. Such marketing activities may include sending promotional and commercial communications regarding services or products offered by Turmeric Group Limited to provide information about our product offerings. These communications may be sent via automated tools (e.g., SMS, MMS, fax, e-mail, web applications, etc.) or traditional marketing channels (e.g. mail, etc.). The legal basis for using the personal information you provide us for this purpose is your consent. If you do not wish to be contacted in connection with our marketing activities, please see **Your data protection rights to** access personal data and other rights" below. You may also disregard our direct mail or online advertisements.

You will be required to provide the above-mentioned consent via online forms available through Turmeric Group Limited. Email us on admin@turmericgroup.com. If you refuse or withdraw your consent for the marketing activities described above, your [personal] data will be processed only for the other purposes described above.

If you provide the above-mentioned consent and receive an e-mail from Turmeric Group Limited, we may use technical cookies to track the following: email-receipt, e-mail opening, any further action you take with respect to the e-mail (e.g., clicking on a link in the e-mail), or your accessing any Turmeric Group services. and viewing at least some portion of the Turmeric Group Services content. Such personal information will be used only for technical reasons, particularly to confirm that the e-mail was correctly sent, and received, as well as to verify for statistical purposes (in aggregated [or anonymized] form) any access to the Turmeric Group Services. Under the circumstances of co-marketing or joint pre-sales activities, your personal data may also be communicated to the involved third parties (e.g. business partners, sponsors, vendors, etc.). This Privacy Notice does not address, and we are not responsible for, the privacy practices of any such third parties who are acting independently of Turmeric Group Limited but we have endeavored to partner with business partners, sponsors, vendors, etc. who are GDPR compliant.

How we store your personal information

Your information is securely stored. We keep Email correspondence for 3 years. We will then dispose your information by permanently deleting the correspondence.

Data retention

Personal data will be retained for as long as we have, or need to keep a record of, a relationship with a business contact, which is for the duration of our relationship with a contact or their organisation. Personal data may be held for longer periods where extended retention periods are required by law or regulation and in order to establish, exercise or defend our legal rights.

Your data protection rights

Under data protection law, you have rights including:

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
